Guidelines

for drivers who enter the protected site of ANWIL S.A.

I. Rules to be applied by drivers entering the protected site of ANWIL S.A.

- Before entering the protected site of ANWIL S.A., a driver, upon confirmation of receipt, shall obtain the Guide for persons who temporarily stay in the territory of ANWIL S.A. from the Security Service.
- 2. An identification card with a granted right to enter, registered in a database of the access control system of ANWIL S.A. is a document entitling to enter the protected site of ANWIL S.A.
- On the protected site of ANWIL S.A. there are applied rules on moving by vehicles stipulated in the currently binding "Traffic Law Act". On the protected site of ANWIL S.A., there is a speed limit of up to 50 km/h unless traffic signs say otherwise.
- 4. Drivers must have documents in accordance with a separate internal organizational act at ANWIL S.A. pertaining to Individual Traffic Instruction. The foregoing documents have to be presented for control to authorized authorities performing control activities both before entry and during movement on the protected site of ANWIL S.A.
- 5. Mechanisms of vehicles entering the protected site of ANWIL S.A. have to be tight without leaks of oils and other exploitation liquids.
- 6. Drivers of vehicles transporting dangerous goods need to comply with the provisions on carriage of dangerous goods by road in particular included in the European Agreement concerning the International Carriage of Dangerous Goods by Road (ADR). Protective equipment for a driver has to be consistent with the written instruction included in the ADR European Agreement.
- 7. All drivers entering the protected site of ANWIL S.A. shall be obliged:
 - a) to become familiarized with, apply and absolutely observe requirements for occupational health and safety, fire protection, process safety and environmental protection included in generally binding provisions and in provisions binding in the territory of ANWIL S.A., included in the Guide for persons who temporarily stay in the territory of ANWIL S.A. and on information boards available in loading/unloading points, driver service offices.
 - b) to use, on the entire protected site of ANWIL S.A., working/protective clothes (long trousers, jacket/blouse with long sleeves), working footwear with toe caps protecting toes (class S-3), protective helmets with a four-point chinstrap, protective glasses, high-visibility vests, gloves and other personal protective

- equipment required, adapted to hazards (refers to drivers leaving a vehicle cabin and participating in transportation works),
- c) to perform instructions of a shift leader (in the case of emergency situations, a shift leader or a person designated by him/her shall be responsible for evacuation and ensuring a gas mask covering whole face with ABEK2 absorber),
- d) to use only devices, tools, materials and equipment fully operational, with appropriate technical permits, attestations, certifications and certificates,
- e) to safeguard a vehicle with wedges, to pull a parking brake and to take out keys from the ignition switch before each unloading/loading. Failure to meet the foregoing requirement shall result in a refusal to unload/load goods,
- f) to continuously supervise correctness of loading/unloading process together with a staff member of ANWIL S.A., supervise the process of loading from a designated place at the loading station,
- g) after finishing loading, the driver is responsible for correct protection of transported cargo and correct protection of semi-trailer,
- h) to undergo a control of speed on the premises of protected facilities, carried out by police officers or staff members of the Security Service of ANWIL S.A. with the use of a radar speed meter,
- i) to undergo a control of sobriety on the protected site of ANWIL S.A., carried out by the Security Services of ANWIL S.A.,
- j) to undergo a control of vehicles both while crossing gates and on the protected site of ANWIL S.A. upon a request of a staff member from the Security Service of ANWIL S.A. or staff member of the Control and Security Office of ANWIL S.A.,
- k) to present passes and identification cards to a staff member of the Security Service of ANWIL S.A. during a control or while crossing gates without a call, binding in ANWIL S.A.,
- to cooperate with other employers in matters concerning occupational health and safety, fire protection and process safety in situations when staff members employed by different employers perform work in the same place,
- m) to observe the ban on using mobile phones in places marked with a ban on using them,
- n) to park a vehicle only in places assigned for this purpose and marked under penalty of withdrawing rights to enter,
- o) to strictly comply with a ban on blocking all roads,
- p) to strictly comply with orders given by persons acting on behalf of ANWIL S.A.,
- q) to immediately inform staff members in charge of loading/unloading station service and the enterprise's controller (phone: 19 998 or 19 112) about all accidents at work, non-injury accidental events which have taken place during performance of works on the protected site of ANWIL S.A.,
- r) to immediately inform staff members in charge of loading/unloading station service and Company Fire Service about all fire incidents (ignition, selfignition, fire) and other local hazards which they will notice during performance of works on the protected site of ANWIL S.A. at alarm phone numbers (19 998),

- s) during announcement of evacuation in facilities / on sites where loading/unloading is carried out to absolutely comply with instructions of a person managing the rescue action and not to use cars for evacuation.
- 8. Tank truck drivers entering the protected site of ANWIL S.A. shall be additionally obliged:
 - a) not to commence any loading or unloading activities without presence of an authorized staff member of ANWIL S.A., in particular activities including linking a tank truck with an installation of ANWIL S.A..
 - b) to connect an earth clamp (if required),
 - c) to absolutely use protective barriers with which tank trucks are equipped (prior to starting works on the tank truck), where required,
 - d) to absolutely use complete, in good technical condition, safety harnesses, equipped with attachment buckles of D type during works on tank trucks,
 - e) to absolutely use belay systems installed in ANWIL S.A. during works on tank trucks (if a given station is equipped with them).
- 9. Activities related to loading/unloading vehicles subject to TDT (Transportation Technical Supervision) should be performed by an authorized Driver.
- 10. During the loading/unloading process carried out by means of motor-driven fork-lift trucks, a driver shall be obliged to agree on cooperation conditions and place of presence with an operator of the fork-lift truck. No outsiders shall stay in the work zone. A driver is forbidden to stay on the vehicle load platform/semi-trailer at the time. If it is necessary to control if cargo has been loaded correctly, a driver may go up a load bed / semi-trailer only after a forklift truck completely stops and informing a forklift truck operator about such a necessity beforehand.
- 11. ANWIL S.A. reserves the possibility of carrying out a control of the works performed by a driver acting on behalf of the Contractor on the protected site of ANWIL S.A. in the range of compliance with binding provisions and rules on occupational health and safety, environmental protection provisions, fire protection and process safety provisions.
- 12. The Contractor declares that:
 - a) drivers performing transportation works on the protected site of ANWIL S.A. shall provide the service in agreement with binding requirements in the range of occupational health and safety, fire protection, environmental protection and process safety included in generally binding provisions and in force on the protected site of ANWIL S.A. and undertakes as well as obliges subcontractors to observe them,
 - b) drivers who perform, on the protected site of ANWIL S.A., transportation works show valid medical certificates on lack of health contraindications to perform these works,
 - c) drivers who perform, on the protected site of ANWIL S.A., transportation works hold qualification entitlements adequate to the kind of the works performed on the above-mentioned area.
 - d) he shall conduct any possible post-accident inquiry in cooperation with a representative of the OHS Office of ANWIL S.A. as well as shall provide the OHS Office of ANWIL S.A. with a copy of post-accident documentation drawn up in accordance with provisions binding within this scope after prior removal

- of personal data of an aggrieved party and other persons indicated in these documents,
- e) he shall respect remarks and orders of representatives of ANWIL S.A. in matters concerning occupational health and safety, fire protection, environmental protection and process safety.
- 13. On the protected site of ANWIL S.A., it is banned to:
 - a) continue driving during a chemical alarm,
 - b) drive trucks and special vehicles with an open load bed,
 - c) drive a tank truck with open flaps, valves, hatches, etc.,
 - d) smoke cigarettes in vehicles and outside them (this also refers to so-called e-cigarettes),
 - e) leave any type of waste,
 - f) repair vehicles on road passageways,
 - g) wash vehicles outside assigned car washes,
 - h) bring in and carry away canisters with fuel unless this fact is documented in a road card,
 - i) trade in fuel (also on car parks and areas in the immediate vicinity of ANWIL S.A),
 - j) carry in and bring in weapons, ammunitions and pyrotechnics,
 - k) photograph, film and sketch without a consent given by the Control and Security Office of ANWIL S.A.,
 - I) use dashcams.

If the supervision service of ANWIL S.A. identifies non-fulfilment of the provisions included in this Appendix or infringement of the provisions and rules on occupational health and safety, fire protection, environmental protection or process safety included in generally binding provisions and binding on the protected site of ANWIL S.A. by a staff member of the Contractor or another person acting on behalf of the Contractor during performance of the works on the protected site of ANWIL S.A., ANWIL S.A. reserves the possibility to impose financial penalties according to the following Scale of financial penalties (point II below). The "Report to punish the Contractor with a financial penalty" (point III below) approved by the Prevention and OHS Director of ANWIL S.A. shall be the basis to impose a financial penalty on the Contractor.
